HFSF Strategic Goals

ACCESS TO HEALTH

By increasing access to routine and preventive medical care for children and adults, it is our goal to improve overall healthcare availability and utilization among uninsured and under served communities.

SOCIAL NEEDS

To reduce health disparities, we will advance a collaborative system, across sectors, that enables and facilitates the integration of social needs and health care.

THRIVING COMMUNITY

With an overall objective to improve the social and economic conditions that promote physical, mental, and emotional well-being, we seek to foster a thriving South Florida by creating awareness about the intersection of community development and health, with a special focus on housing and economic prosperity issues.

Project Goals

The Foundation seeks to cultivate **Health Equity Collaboratives** to foster social and health integration models. These collaboratives can already be in place or can be newly formed to address needs outlined in the Notice of Funding Opportunity.

The goals of these collaboratives and the pilot projects they implement are to:

- Build infrastructure that will support improving health outcomes for South Floridians who have low incomes and are racial and ethnic minorities by **integrating social needs and clinical care**.
- Generate data on the return on investment from **integrating social needs and clinical care**.
- Build sustainable and scalable models of **integrated social needs and clinical care** that have stable, ongoing funding sources.



Notice of Funding Opportunity

What is required?

WHO

Applicants with at least one healthcare organization or payer and at least one community-based public health or social service organization.

WHAT

We seek proposals from multi-sectoral partners that clearly demonstrate:

- An identified population and/or health condition focus;
- Understanding of evidence-based approaches and plans;
- Commitment to equitable engagement, processes, and plans;
- Technology enabled solutions;
- Plans for sustainability.

Eligibility & Criteria

ELIGIBILITY

Safety net providers (e.g., FQHCs, hospitals, community-based clinics, payers, and community-based organizations) working collaboratively to help transform the South Florida health delivery system, specifically in Broward, Miami-Dade, and/or Monroe counties

FISCAL MANAGEMENT

One organization within the collaborative may serve as the fiscal agent to partners, and must provide prompt and timely payment to partners

HOW TO APPLY

1. Submit an application to the NOFO using the google form on the HFSF website
2. After reviewing applications, Foundation staff will notify selected applicants

Areas of Focus

- **Black maternal and infant health**
- **Health Care Access Barriers**
- **Chronic Disease Disparities**
- **Other (substantiated by data)**

Important Deadlines and Meetings

- Notice of Funding Opportunity Posted: **October 13, 2022**
 - Question Submission Deadline: **November 3, 2022**
 - Application Due: **November 18, 2022 by 12 Noon (EST)**
 - Award/Declination Notification: **December 1, 2022**

Planning and Development workshops will be convened in-person and virtually.

Participation is required for the following dates:

- Virtual: **December 9, 2022**

Funding Range

PLANNING PHASE GRANTS

\$17,500 per health equity collaborative

IMPLEMENTATION GRANTS

Upon completion of a successful planning phase, grantees may be eligible for multi-year investments with an average grant size of \$350,000 - \$500,000 per collaborative. However, projects will be considered on a case-by-case basis.

Milestones & Funding for Planning Phase

First Level Milestones (\$5,000 for completion)

- Collaborative Leaders from each organization listed in the application participate in December Workshop.
- MOUs obtained from partners listed in the application.
- Collaboration Team Charter developed.

Second Level Milestones (\$5,000 for completion)

- Collaborative Leaders from each organization listed in the application participate in January Workshop.
- Implementation Plan drafted.

Third Level Milestones (\$7,500 for completion)

- Collaborative Leaders from each organization listed in the application participates in February and March Workshops.
- Key activities identified for addressing the problem identified within the application, based on the evidence-based, evidence-informed, or promising practice approach selected.
- Project Funding/Budget Request submitted to HFSF.
